Admissions Policy for Yew Tree Community School

Aims

This policy aims to:

- explain how to apply for a place at the school;
- set out the school's arrangements for allocating places to the pupils who apply; and
- explain how to appeal against a decision not to offer your child a place.

Legislation and statutory requirements

This policy is based on the following advice from the Department for Education (DfE):

- School Admissions Code
- School Admission Appeals Code

As an academy, the school is required by its funding agreement to comply with these codes, and with the law relating to admissions as set out in the School Standards and Framework Act 1998.

How to apply

For applications in the normal admissions* round you should use the application form provided by your home local authority (regardless of which local authority the schools are in). You can use this form to express your preference for a minimum of 3 state-funded schools, in rank order.

You will receive an offer for a school place directly from your local authority.

Please note, pupils already attending our nursery will not transfer automatically into the main school. A separate application must be made for a place in reception.

* The **normal admissions round** is the period during which parents can apply for state-funded school places at the school's normal point of entry, using the common application form provided by their home local authority.

Requests for admission outside the normal age group

Parents are entitled to request a place for their child outside of their normal age group. Decisions on requests for admission outside the normal age group will be made on the basis of the circumstances of each case and in the best interests of the child concerned. In accordance with the School Admissions Code, this will include taking account of:

- parents' views;
- information about the child's academic, social and emotional development;
- where relevant, their medical history and the views of a medical professional;
- whether they have previously been educated out of their normal age group; and
- the Head of School's views.

Wherever possible, requests for admission outside a child's normal age group will be processed as part of the main admissions round. They will be considered on the basis of the admission arrangements laid out in this policy, including the oversubscription criteria listed. Applications will not be treated as a lower priority if parents have made a request for a child to be admitted outside the normal age group.

Parents will always be informed of the reasons for any decision on the year group a child should be admitted to.

Parents do not have a right to appeal if they are offered a place at the school but it is not in their preferred age group.

Section 22(1) of the Children Act 1989, is remanded or detained into Local Authority accommodation under Criminal Law or who has been placed for adoption. Evidence may be requested from carer's whose children are looked after or were previously looked after by another Local Authority. Children adopted from state care outside of England Children who appear (to the Trust) to have been in state care outside of England and ceased to be in state care as a result of being adopted will be given equal first priority in admission arrangements, alongside looked after children (LAC) and children who were previously looked after by English local authorities (PLAC). These children are referred to as internationally adopted previously looked after children -"IAPLAC". Evidence will be required from the carer confirming that their child meets the above criteria in accordance with the DfE's non-statutory guidance on the admission of IAPLAC. Sibling Siblings (brothers or sisters) are considered to be those children who live at the same address and either: i. have one or both natural parents in common: or ii. are related by a parent's marriage; iii. are adopted or fostered by a common parent. Unrelated children living at the same address, whose parents are living as partners, are also considered to be siblings. Children not adopted or fostered or related by a parent's marriage or with one natural parent in common, who are brought together as a family by a same sex civil partnership and who are living at the same address, are also considered to be siblings. Distance Distances are calculated on the basis of a straight-line measurement between the applicant's home address the main entrance of the school. The Local Authority uses a computerised system, which measures all distances in metres. Ordnance Survey supply the co-ordinates that are used to plot an applicant's home address and the address of the school. Parents who wish to appeal against the decision to refuse their child admission should visit www.birmingham.gov.uk/schooladmissions In Year Applications made outside the normal admissions round **Applications** (in-year admissions) should be made directly to the School. Parents/carers can apply for a place for their child at any time and to any School. On receipt of an inyear application, the School will notify the local authority of both the application and its outcome, to allow the local authority to keep up to date with figures on the availability of School places in Birmingham. Deferred entry Parents can request that the date their child is admitted to and Admission of school is deferred until later in the academic year or until children outside the term in which the child reaches compulsory school their normal year Parents have the right to request, but not insist, that their group child be considered for admission to a class outside of their normal age group. This could be the case, for example, if a child is gifted and talented, has experienced problems such as ill health, or that the child is summer born, i.e. a child born between 1st April and 31st August. Parents who wish for their child to be considered for admission to a class outside of their normal age group must make an application for the normal age group in the first instance. Parents must then submit a formal request to the Trust for the child to be considered for a different age group class instead. This request should be in the form of a written letter of application outlining the reasons why they wish for their child to be considered to be

admitted into a class outside of their normal age group and enclosing any supportive evidence and documentation that they wish to be taken into account as part of that request.

The Trust will consider requests submitted for a child to be admitted into a class outside of their normal age group and advise parents of the outcome of that request before national offer day, having taken into account the information provided by the parents, the child's best interests and the views of the Head Teacher.

If the request is refused, the original application for the normal age group class will progress through the Local Authority co-ordinated admissions scheme, be considered by the Trust and the parents advised of the outcome.

If the request is agreed and the year group for which the parents have requested a place is a current year group in the school, then the application will be considered by the Trust and the parents advised of the outcome.

If the request is agreed and the year group for which the parents have requested a place is for a future year group, ie Reception in September 2024, then the original application is withdrawn and the parents must submit a fresh application for Reception 2024 when applications open in the autumn term of 2023. Please note that parents only have the right to re-apply for a place. Where the Trust agrees to consider an application for Reception the following year, that application is considered alongside all other applications received and parents will be advised of the outcome of that application on national offer day. No place is reserved or held for the child in advance.

Fair Access Protocol

The Trust of Yew Tree Community School is committed to taking its fair share of children who are vulnerable and/or hard to place, as set out in locally agreed protocols. Accordingly, outside the normal admission round the Trust is able to give priority to a child where admission is requested under any locally agreed protocol. The Trust has this power, even when admitting the child would mean exceeding the published admission number subject.

Yew Tree Community School Nursery

In Nursery our classes we are able to offer a number of part-time places with children being entitled to 15 hours per week.

Part-time places will be allocated on a morning or afternoon basis.

Part-time places are offered on a basis of need, based on the following criteria:

- Social Services referral;
- Special Educational Needs;
- where a sibling is already attending the school.

Within each of these categories, priority is given to those who live nearest to the school, by straight line measurement to the school's front gates.

Where the local authority has agreed a catchment area for the school, children living within that area have priority over those children living outside it.

If vacancies occur because of pupils not taking up places or leaving school, places continue to allocate according to the above criteria.

Admitting children in to the Nursery in the term following their third birthday

The school can use its discretion to determine if it is in a position to admit pupils that reach the age of three following the start of the academic year. In the event that we are oversubscribed, the same admissions criteria for nursery places would be applied.

30 hours funded place

All Nursery children are entitled to a 15 hour funded place. Children of parents who meet additional criteria may be entitled to a 30 hour funded place (upon completion of application through www.gov.uk and presentation of an eligibility code to the school). It is the parent's sole responsibility to complete the application and submit the eligibility code and date of birth to the school by the deadline stipulated.

All parents that are interested in a 30 hour funded nursery placement are required to indicate to the school that they will be submitting an application to www.gov.uk as they meet the criteria for 30 hours free childcare. This must be done by completing the school's Nursery Full-Time Place Application Form and submitting it to the school before the deadline date specified. Full-time places cannot be guaranteed if applications are received after the deadline date.

Parents are still eligible for 15 hours free childcare even if they do not meet the criteria for 30 hours. The following website provides further information: https://www.gov.uk/help-with-childcare-costs/free-childcare-and-education-for-2-to-4-year-olds.

Nursery full-time place

If capacity exists, parents will have the option to top up their 15 funded hours to 30 hours by paying a fee to the school. This must be done by completing the school's Nursery Full-Time Place Application Form and submitting it to the school before the deadline date specified. Priority will be given in accordance with the nursery admissions criteria.
